- 21 Day/250 Mile DealShield Return guarantee.
- All vehicles with a selling price up to \$35,000
- Vehicles must have AutoGrade Condition Report of 2.0 or higher and a sold price at 90-110% of National MMR.
- Protection applies only to purchased vehicles facilitated by Manheim
- Vehicle buyer may return the vehicle for any reason *and will be reimbursed 100% of purchase price and the OVE buy fee.
- Dealers that are not otherwise eligible for coverage under DealShield's buyer protection will not be entitled to the benefits of the DealShield 21-Day Return Guarantee being offered under the promotion.
